New Director of Programs at the CFI

Mark Lagacé is the new Director of Programs at the Canada Foundation for Innovation. He began this role on July 11, 2022. Mark joined the CFI in April 2005 as an Assistant Coordinator and since then has played key roles on the Programs team including as Manager of the Leaders Opportunity Fund from 2006 to 2008 and then as Senior Programs Officer. He has led or co-led at least five national competitions starting with the 2012 Leading Edge and New Initiatives Funds and most recently the Biosciences Research Infrastructure Fund.

Mark holds a PhD in Microbiology and Immunology from the University of Ottawa. He brings rich experience in leadership and management of funding competitions and a profound working knowledge of the CFI. We are very happy to have Mark at the helm of the Programs team.

The latest on the 2023 Innovation Fund competition

By the July 15, 2022 deadline, we received 297 proposals to the 2023 Innovation Fund competition from 63 institutions. Together, these proposals amount to over \$1.1 billion from the CFI, representing total project costs of over \$3.1 billion.

The first part of the review process, virtual Expert Committee meetings, will take place from late September 2022 to mid-January 2023. Programs staff are finalizing the recruitment of members for these committees.

Annual reporting requirements and institutional payments

We would like to thank institutions for submitting their financial and project progress reports (PPRs). Once again this year, we have benefited from outstanding support from institutions, with submission rates of 71 percent for financial reports and 98 percent for PPRs. We rely on the data collected through the PPRs to develop our annual report on results, one of the key accountability tools we use to demonstrate the outcomes of CFI research infrastructure funding.

We use the financial reports to assist in the management of projects. We perform follow-up procedures on issues we identify from the reports. Your response to these issues is important and we encourage you to address them as soon as possible. The submission deadline for final financial reports is September 30, 2022, if you did not submit an interim financial report this year. Note that an Infrastructure Operating Fund annual report is due annually on June 15, regardless of whether your institution has any actual or forecasted expenditures to report.

For institutions with financial or project progress reports still outstanding, please be advised that future installments for all CFI-funded projects (including new awards to be finalized, if any) will be held back if these reports are not received by November 15, 2022. Installments will resume once all reports have been submitted. Reminders will be sent to the CFI account administrator and the CFI liaison during the first week of October advising them of any outstanding reports. You can also consult your institutional overview page in the CFI Awards Management System at any time to view your overdue reports.

Reaching out to researchers

A reminder that in February 2022, we launched an initiative to encourage researchers to think of the CFI when they communicate about their infrastructure and the research that emerges from it. This includes information about joining the Research Facilities Navigator and order forms for CFI-branded stickers.
