#### A new organizational structure for our Programs and Planning team

We have reorganized our Programs and Planning team into four groups: research facilities; Innovation Fund and special funds; annual funds (John R. Evans Leaders Fund (JELF) and the College Fund); and programs operations. We have also introduced a planning and project management function to help coordinate our activities. These changes are a result of a review of our organizational structure and responsibilities and are made to ensure that the team structure reflects the current and future needs of the CFI and its stakeholders. Over the next few months, you will notice some changes as the teams take on their new responsibilities. In the meantime, your assigned Senior Programs Officer (including those who are now Associate Directors) and Programs Officer are still your main points of contact.

### Biosciences Research Infrastructure Fund – Partnership with Stage 2 of the Canada Biomedical Research Fund

The results of the Biosciences Research Infrastructure Fund competition for biocontainment and large-animal facilities were announced in November. Through that first BRIF competition, the CFI invested over \$127 million to help eligible institutions keep their facilities at the cutting edge and support the Government of Canada's **Biomanufacturing and Life Sciences Strategy** to advance promising discoveries and promote training and talent development in the biosciences.

Through the second competition of this funding program, called Biosciences Research Infrastructure Fund – Partnership with Stage 2 of the Canada Biomedical Research Fund (CBRF-BRIF Stage 2), the CFI will award the remaining BRIF funds allocated in the 2021 federal budget. The goal of the second competition is to grow a strong and competitive biomanufacturing and life sciences sector and ensure our country is prepared for future pandemics. The CFI will invest up to \$360 million through BRIF to support research infrastructure needs while up to \$225 million will be invested over four years through CBRF to support high-risk, applied research, and training and talent development.

In advance of the BRIF–CBRF Stage 2 competition, expected to be launched in winter 2023, we encourage institutions interested in applying to this fund to verify their eligibility. Institutions must be eligible to apply to the CFI as well as to one of the three federal research funding agencies to apply to this competition.

To verify your institution's eligibility, consult **our list of eligible institutions** as well as the list of eligible institutions for the **Canadian Institutes of Health Research (CIHR)**, the **Natural Sciences and Engineering Research Council of Canada (NSERC)** or the **Social Sciences and Humanities Research Council of Canada (SSHRC)**.

Looking to reduce the carbon footprint of your institution's CFI-funded research infrastructure? If your institution has policies for carbon offsetting, claiming offset costs may be an option. The CFI recognizes carbon offsets as eligible operating costs under the Major Science Initiatives Fund and Infrastructure Operating Fund. Institutions are required to follow their usual purchasing and applicable institutional policies and procedures when selecting a carbon offset program. You must document and keep on file the methodology used to determine the total amount of carbon offset costs reported to the CFI and be prepared to provide this information upon request.
