National announcement for the Innovation Fund

We are currently in discussions with the Government of Canada to determine a date for the national announcement of the funding results of the 2017 Innovation Fund. We will keep you informed of details as we have them. In the meantime, as usual, please keep your Innovation Fund funding under embargo until it is announced.

Internal selection process for the Innovation Fund

Institutions submitting proposals to the 2017 Innovation Fund competition were asked to provide a short description of their internal decision-making process in the selection of proposals for this competition. The CFI undertook a careful synthesis and analysis of the 81 submissions made by institutions. The enclosed report, titled Innovation Fund: Internal selection process, will be published on our website. We hope it will enhance the dissemination and sharing of good practices in all areas of CFI institutional activity. It has also allowed the CFI to gain valuable insights on how institutions set priorities and make strategic choices in the selection of their projects; we hope you will find our summary report to be useful.

New campaign featuring young researchers

By giving young researchers the tools they need to think big and innovate, the CFI builds potential in people, in institutions and in Canada. This fall, the CFI is launching a promotional campaign featuring student and early career researchers from across Canada. The #IAmInnovation campaign aims to show how the CFI plays a critical role in creating the environments where the next generation of researchers find their inspiration, their highly skilled training, their mentors and the roadmaps to their future, ultimately improving Canadians' lives.

Annual reporting requirements

We would like to thank institutions and project leaders for submitting their financial and project progress reports (PPRs). Once again this year, the CFI has benefited from outstanding support from institutions, with submission rates for these reports of 80 percent and 99 percent respectively. Thank you!

The financial reports are used by the CFI to assist in the proper management of projects. We also perform follow-up procedures on issues identified in the review of the financial reports. Your response to these issues is important and we encourage you to address any outstanding issues as soon as possible. As happens every year, the majority of outstanding reports are final financial reports (submission deadline of September 30); we expect these to be submitted in early October.

We rely on the data collected through the PPRs to develop our annual [Report on results](#), one of the key accountability tools that we use to demonstrate the outputs and outcomes of CFI-funded research infrastructure.

For the few institutions where financial or project progress reports are still outstanding, please be advised that future installments for all CFI-funded projects (including new awards to be finalized, if any) will be held back if these reports are not received by November 15, 2017. Installments will resume once all reports have been submitted. Reminders will be sent to the CFI account administrator and the CFI liaison during the first two weeks of October advising them of any outstanding reports.

CFI @ CARA 2017 regional meetings and le Colloque 2017 de l'ADARUQ

As we have done for several years, we will attend all three 2017 CARA regional meetings in St. John's, Toronto and Victoria, and le Colloque 2017 de l'ADARUQ in Shawinigan. These meetings provide the CFI with unique opportunities to meet and catch up with so many of our institutional contacts, new and old. In addition to our regular CFI update session, we are planning to provide an update on the work of the working group on multi-institutional proposals, which we struck this summer.

Annual Major Science Initiatives (MSI) workshop coming in October

The fourth MSI workshop entitled “Supporting Canada’s research communities” will be held in Ottawa on October 19 to 20, 2017. This workshop will be a great opportunity for all 17 MSI-funded national research facilities to network and share experiences on the challenges of governing, managing and sustaining the operations of such facilities.

Desired outcomes of the workshop include:

- Sharing knowledge and experience with best practices and common challenges that arise for both CFI and MSI facilities;
- Building connections and relationships across the MSI community;
- Informing MSI representatives of new policies, requirements, changes in CFI procedures under the MSI Fund;
- Looking ahead for future opportunities for the MSI Fund and supported facilities.

College-Industry Innovation Fund – Stream 2 — we’ve made a few improvements

We announced in the March 2017 issue of this newsletter that we would participate in the 15th competition of the Tri-Agency’s College and Community Innovation (CCI) Program – Innovation Enhancement (IE). As such, the CFI will accept research infrastructure requests associated with CCI Build IE grant applications submitted to NSERC. The deadline for completing both the NSERC and CFI online forms is October 26, 2017.

Since the inception of the program, the College-Industry Innovation Fund – Stream 2 application form has been an abbreviated version of the form used for Stream 1. The CFI has now completely revised the application form for the 2017 competition and future competitions. The form was modified not only to factor in the significant changes that had been made to the Stream 1 application form (in effect since the 2016 Stream 1 competition) but also to eliminate undue redundancies with the content of the CCI Build IE form. In the streamlined application to Stream 2, the number of selection criteria to be addressed by the applicants is now reduced from five to one (i.e. the “infrastructure” criterion, which focusses on and regroups all aspects pertaining to the requested infrastructure). These improvements introduce consistency between Stream 1 and 2 and allow for harmonizing the review criteria and fund objectives between the two streams. Most importantly, these improvements will certainly reduce the burden on both applicants and reviewers.
